This will be a closed (Sealed) bid auction. The minimum required bid will be **\$4000**. All sealed bids must be presented to Picosa water board by November 21@ 6:00 pm. On November 21 at that monthly Picosa Water Board Meeting, the Board will be opening up all bids at that time. Picosa will be selling the vehicle to the highest bidder that was submitted. If there is a tie with the bid amount, the bid that was sent to Picosa the earliest will be the winning bid, we will not accept a late bid by mail. All Bids will be stamped in at the office once received. Picosa will not be responsible for the post office delays, so if you mail your bid to Picosa water supply, make sure you do it prior to the bid date and give plenty of time for the bid to get mailed. You can always drop the bid off in the deposit box where you pay your bills or bring it in during business hours. Feel free to research the VIN number as we've already done that. Picosa will post a picture of the value from Kelley blue book. The Blue book value is identical when you put the AC not working. **The AC in the truck does not work**. This will be an **"AS IS"** sale. The winning bid will have five business days to make a cash payment/Check to Picosa Water Supply. If payment is not made within five days of the winning date. Picosa will go to the second highest winning bidder. The second highest bidder, then will have five days to make a cash payment/check. If they do not make the payment, Picosa will go to the third highest bidder and so on and so on, until the vehicle is sold.

Picosawater will have blank forms for you to put a bid on in the office or you can drop them off in the box when you make your payments. Make sure you place them in a sealed envelope. No one will ever see your bid until the night of the meeting. There will be a locked box in the office for you to place the bids in. If you mail your bids in to the office. They will get a time stamp on them. If you drop it in the Drop box, it will get a time stamp on the next morning. If you hand carry it to the office make sure you have Picosawater Time stamp it before you place it in the box.

The Board of Directors will open up all bids that we submitted by the deadline and read at the monthly meeting and we will announce at that meeting who the winning bidder is. Picosawater will announce the top three winning bids. We are attaching pictures to our website so you may look at them and if you would like to look at the truck, you may come to Picosawater supply to take a look at the vehicle. We will start the vehicle out for you so you can take a look at it. You will not be allowed to drive it since Picosawater does not have insurance on it for other drivers, (We only Insurance for Picosawater employees).
